## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 14ct yellow gold, gem set, 'three stone' style ring, of cast construction.

Plain, narrow, low half round band of 1.23mm width (at base) x 1.11mm depth, with open back settings, and a curved underrail.

Feature central railed four claw setting, housing one round brilliant cut diamond, claw set. The setting is secured between the shoulders of the plain and polished band. Each of the shoulders is embellished with triangular shaped plates, one round brilliant cut diamond, bead set, and finished with millegrain detail.



Polished finish.

Stamped '14K KD' - acid tested as 14 carat gold.

Ring size: M.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "J".

Dimensions = 4.92mm(L) x 4.91mm(W) x 3.15mm(D-estimated) x 4%(Girdle Thickness)

Total Weight = 0.48ct (estimated - see NOTE below)

Two bead set round brilliant cut diamonds, clarity is "Si", colour is "I to J" (mixed).

Dimensions (average) = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.03ct (estimated - see NOTE below)

Total Item Weight = 1.59 grams Total Gemstone Weight = 0.51ct Total Metal Weight = 1.49 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
