Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.51mm width (at base) x 1.48mm depth, with a curved underrail.

Feature round top plate, housing nine round brilliant cut diamonds, varying in size, and claw set. Surrounding is one row of sixteen round brilliant cut diamonds, claw set. The gallery and shoulders are embellished with a total of twenty-eight round brilliant cut diamonds, varying in size, and claw set. The top is secured between the extended and square shoulders, of the plain and polished band.



Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: S.

The ring contains:

Four claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 2.60mm(Dia) x 1.59mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.26ct (estimated - see NOTE below)

Forty Nine claw set round brilliant cut diamonds, clarity is "Vs & Si & P1 & P2 & P3" (mixed), colour is "G to H" (mixed).

Dimensions = 1.00mm(Dia) x 0.61mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.60mm(Dia) x 0.98mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.54ct (estimated - see NOTE below)

Total Item Weight = 5.47 grams Total Gemstone Weight = 0.80ct Total Metal Weight = 5.31 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
