Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'solitaire' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.65mm width (at base) x 0.91mm depth, with a curved underrail.

Feature central white gold six claw setting, housing one round brilliant cut diamond, claw set. The setting is secured to the underrail, and in between the extended and pointed shoulders, in a 'wrap around' style, of the plain and polished yellow gold band.

Polished finish.

Stamped '50 18ct BEV' - acid tested as 18 carat gold.

Ring size: R.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P2", colour is "I".

Dimensions = 4.80mm(L) x 4.77mm(W) x 3.30mm(D-estimated) x 3.5%(Girdle Thickness)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 4.68 grams

Total Gemstone Weight = 0.50ct

Total Metal Weight = 4.58 grams (estimated)
