## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 3.70mm width (at base) x 0.77mm depth, with a curved underrail.

Feature central white gold 'flower' style cluster, housing six round brilliant cut diamonds, claw set. The top plate is supported with an open wire base, and is secured to the underrail, and in between the extended and square shoulders, of the plain and polished yellow gold band.



Polished finish.

Unstamped - acid tested as 18 carat gold.

Ring size: O.

The ring contains:

Six claw set round brilliant cut diamonds, clarity is "Si & P1 & P2 & P3" (mixed), colour is "H to I" (mixed).

Dimensions = 3.56mm(Dia) x 2.17mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.64mm(Dia) x 2.22mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.02ct (estimated - see NOTE below)

Total Item Weight = 7.90 grams Total Gemstone Weight = 1.02ct Total Metal Weight = 7.70 grams (estimated)

NOTE: One of the surround diamonds is broken. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
