## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, flat, tapered band of 3.64mm width (at base) x 1.06mm depth, with open back settings, and a curved underrail.

Feature two oval natural sapphires, alternating with two round brilliant cut diamonds, spanning across the top of the band, and claw set. There are a total of six round brilliant cut diamonds, claw set. The top plate is supported with an open wire base, and is secured between the extended and tapering shoulders of the plain and polished band.



Polished finish.

Stamped '18ct' - acid tested as 18 carat gold.

Ring size: N.

The ring contains:

Two claw set oval shaped natural sapphires, colour is "blue/green".

Dimensions (average) = 6.60mm(L) x 5.47mm(W) x 3.34mm(D-estimated)

Total Weight = 2.00ct (estimated - see NOTE below)

Six claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to I" (mixed).

Dimensions (average) = 2.10mm(Dia) x 1.28mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.21ct (estimated - see NOTE below)

Total Item Weight = 7.47 grams Total Gemstone Weight = 2.21ct Total Metal Weight = 7.03 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
