Valuation for Traditional Retail Insurance Replacement

Item 1

One pair of hand-assembled, 9ct white gold, diamond set earrings.

Feature 'tear-drop' shape earring design, having eight single cut diamonds, to each centre dome. Surrounded by twenty-two tapered baguette cut diamonds, tapering in size, channel set. Finishing with the outer row of thirty-one single cut diamonds, claw set.

Post and butterfly fittings attached.

Polished finish - stamped '9K 0.50CT' - acid tested as 9 carat gold.

Earring dimensions = 13.83mm (ave. length) x 11.62mm (ave. width) x 4.02mm (ave. depth).

The earrings contain:

Seventy Eight claw set single cut diamonds, clarity 'Si, P1 & P2' (mixed), colour 'G to I' (mixed).
Dimensions = 0.80mm to 0.90mm (diameters)
Total Weight = 0.23ct (estimated - see NOTE below)

Forty Four channel set tapered baguette cut diamonds, clarity 'Si & P1' (mixed), colour 'G to I' (mixed).
Dimensions = 1.30mm(L) x 0.90mm(W) x 0.55mm(D-estimated) x 2%(Girdle Thickness) (smallest)
Dimensions = 2.00mm(L) x 1.20mm(W) x 0.65mm(D-estimated) x 2%(Girdle Thickness) (largest)
Total Weight = 0.27ct (estimated - see NOTE below)

Total Item Weight = 2.86 grams - Total Gemstone Weight = 0.50ct - Total Metal Weight = 2.76 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
