Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand-assembled raised, 18ct yellow and white gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 1.48mm width (at base) x 1.07mm depth, with cut-out underrail, open back settings, underneath.

Feature, "trilogy style" ring design. Comprising, a raised trilogy rub-over settings, in whit gold. Housing three round brilliant cut diamonds, rub-over set. The extended shoulders, of the yellow gold band, taper up to the top, from both sides.

Polished finish, stamped "18ct 2275" - acid tested as 18 carat gold.

Finger size = L.

The ring contains;

Three rub over set round brilliant cut diamonds, clarity is "Si", colour is "G/H"(inset), medium cut quality.

Dimensions = 3.42mm (average diameter) x 2.20mm (D-estimated) (smallest)

Dimensions = 4.47mm (average diameter) x 2.71mm (D-estimated) (largest)

Total Weight = 0.65ct (estimated - see NOTE below).



Total Item Weight = 2.61 grams, Total Gemstone Weight = 0.65ct, Total Metal Weight = 2.48 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
