Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished, raised 9ct rose gold & diamond set, cluster dress ring. Plain, narrow, low half round, tapered band, measures 1.60mm width (at base) x 1.31mm depth, with open back, underneath.

Feature, "cluster style" ring, with shoulder stones. Comprising, a raised four claw setting to top, houses one round brilliant cut diamond, illusion claw set, rhodium plated to highlight in the setting. Drops to a square cushion-shaped surround, housing twenty round brilliant cut diamonds, bead set. The extended shoulders, of the band taper up to the top, splits to a v-shaped termination. Each shoulder contains fourteen round brilliant cut diamonds, bead set, both sides.



Polished finish, stamped "heart/heart, N, 375, WB" - acid tested as 9 carat gold. Finger size = N.

The ring contains;

One illusion claw set round brilliant cut diamond, clarity is "Si", colour is "I", medium cut quality.
Dimensions = 2.80mm (average diameter) x 1.72mm (D-estimated)
Total Weight = 0.08ct (estimated - see NOTE below).

Forty Eight bead set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "I to J" (mixed), medium cut quality.
Dimensions = 0.75mm (average diameter) x 0.46mm (D-estimated) (smallest)
Dimensions = 0.85mm (average diameter) x 0.52mm (D-estimated) (largest)
Total Weight = 0.12ct (estimated - see NOTE below).

Total Item Weight = 2.69 grams, Total Gemstone Weight = 0.20ct, Total Metal Weight = 2.65 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
