Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's, hand finished, raised 14ct white gold & diamond set, multistone ring.

Plain, narrow, low half round, tapered band, measures 1.53mm width (at base) x 1.02mm depth with curved underrail, pierced shoulders, underneath.

Feature, single claw set row, runs across the top of the band. The extended shoulder of the band, tapers up to the top, from both sides.

Polished finish, stamped "14K (faded)" - acid tested as 14 carat gold.

The ring contains;

Sixteen claw set round brilliant cut diamonds, clarity is "P2 & P3"(mixed), colour is "G to H"(mixed), medium cut quality.

Dimensions = 1.70mm (average diameter) x 1.04mm (D-estimated) (smallest)

Dimensions = 1.90mm (average diameter) x 1.16mm (D-estimated) (largest)

Total Weight = 0.38ct (estimated - see NOTE below).

Total Item Weight = 1.93 grams, Total Gemstone Weight = 0.38ct, Total Metal Weight = 1.85 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
