## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, hand-assembled, 21ct yellow gold, dress style, gem set ring.

Plain, narrow band of 2.44mm in width (at base) x 0.50mm depth, with open back setting.

Feature bezel setting, housing one oval-shape cabochon cut lapis lazuli type material, rub-over set. The outer frame of a decorative design, all secured between the split shoulders of the plain and polished band.

Polished finish.

Stamped '21K' - acid tested as approximately 21 carat gold.

Finger size is M.

The ring contains:

One rub over set oval shape cabochon cut lapis lazuli type material.

Dimensions = 22.36mm(L) x 13.35mm(W) x 4.30mm(D-estimated)

Total Item Weight = 6.97 grams.

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
