One, 14ct white gold, gem set, 'solitaire' style ring, of cast construction.

Plain, narrow, low half round band of 1.64mm width (at base) x 1.22mm depth, with an open back setting.

Feature central railed six claw setting, housing one synthetic laboratory grown diamond, claw set. The setting is secured between the shoulders of the plain and polished band.



Polished finish.

Stamped '14K michael hill LGD 541276603' - acid tested as 14 carat gold.

Ring size: N.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "H".

Dimensions = 5.26mm(L) x 5.21mm(W) x 3.20mm(D-estimated) x 3.6%(Girdle Thickness)

Total Weight = 0.54ct (known weight - see NOTE below)

Total Item Weight = 2.14 grams Total Gemstone Weight = 0.54ct Total Metal Weight = 2.03 grams (estimated)

NOTE: The synthetic laboratory grown diamond has been certified by and is the opinion of Messrs. International Gemological Institute, Certificate no. LG541276603 Dated August 5, 2022. The synthetic laboratory grown diamond has also been laser inscribed upon the girdle with IGI (logo) and LABGROWN and LG541276603. Due to setting constraints, the exact dimensions of the synthetic laboratory grown diamond cannot be ascertained. Therefore, weight of the synthetic laboratory grown diamond is very much an estimation. For an accurate weight, colour, and clarity grading, the synthetic laboratory grown diamond requires removal from the setting. No synthetic laboratory grown diamond certificate or paperwork was presented at the time of this valuation. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
