Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.04mm width (at base) x 0.99mm depth, with open back settings, and a curved underrail.

Feature 'vintage; style ring with a central white gold decorative eight claw setting, housing one round brilliant cut diamond, claw set. The setting is secured to the underrail, and in between the shoulders of the plain and polished yellow gold band. Each of the white gold shoulder plates, is embellished with millegarin detail and two single cut diamonds, bead set.

Polished finish.

Stamped '750 JM' - acid tested as 18 carat gold.

Ring size: N.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si2", colour is "G".

Dimensions = 4.17mm(L) x 4.16mm(W) x 2.41mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.25ct (estimated - see NOTE below)

Four bead set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "H to I" (mixed).

Dimensions (average) = 1.32mm(Dia) x 0.81mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.04ct (estimated - see NOTE below)

Total Item Weight = 2.35 grams Total Gemstone Weight = 0.29ct Total Metal Weight = 2.29 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
