Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 1.89mm width (at base) x 1.29mm depth, with open back settings, and a curved underrail.

Feature central illusion setting, within a four claw setting, housing one round brilliant cut diamond, illusion set. The setting is secured to the underrail of the plain and polished band. Each of the extended and square shoulders houses one row of five round brilliant cut diamonds, graduating in size, and channel set.



Polished finish.

Stamped '14K MHJ 0.62 TDW' - acid tested as 14 carat gold.

Ring size: O.

The ring contains:

One illusion set round brilliant cut diamond, clarity is "P1 & P2" (mixed), colour is "G"

Dimensions = 3.70mm(Dia) x 2.40mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.20ct (estimated - see NOTE below)

Ten channel set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "G".

Dimensions = 2.22mm(Dia) x 1.35mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.40mm(Dia) x 1.46mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.42ct (estimated - see NOTE below)

Total Item Weight = 3.26 grams Total Gemstone Weight = 0.62ct Total Metal Weight = 3.14 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
