Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, raised 14ct white gold & diamond set, multistone ring.

Plain, narrow, low half round, tapered measures 2.03mm width (at base) x 1.34mm depth, with curved underrails.

Feature, "cluster style" ring design, with shoulder stones. Comprising, a raised, four claw setting, to top centre, houses one round brilliant cut diamonds, claw set. Drops to a surround, housing fourteen round brilliant cut diamonds, bead set. The extended shoulders, of the band & undercarriage walls, contain twenty two round brilliant cut diamonds, bead set.

Polished finish, stamped "14K michael hill 0.80" - acid tested as 14 carat gold.

Finger size = H.

The ring contains;

One claw set round brilliant cut diamond, clarity is "P2", colour is "H", medium cut quality.

Dimensions = 4.93mm (average diameter) x 3.01mm (D-estimated)

Total Weight = 0.44ct (estimated - see NOTE below).

Thirty Six bead set round brilliant cut diamonds, clarity is "Si, P1 & P2"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 1.40mm (average diameter) x 0.85mm (D-estimated) (smallest)

Dimensions = 1.69mm (average diameter) x 1.03mm (D-estimated) (largest)

Total Weight = 0.36ct (estimated - see NOTE below).

Total Item Weight = 2.92 grams, Total Gemstone Weight = 0.80ct, Total Metal Weight = 2.76 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
