Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.71mm width (at base) x 1.44mm depth.

Feature central two claw setting, housing one marquise cut diamond, claw set. The setting is secured between the extended and pointed shoulders, of the plain and polished band. Each of shoulders houses one row of eight round brilliant cut diamonds, graduating in size, and claw set.



Polished finish.

Stamped '750 R 0.44 ZT D' - acid tested as 18 carat gold.

Ring size: L.

The ring contains:

One claw set marquise cut diamond, clarity is "Si1", colour is "H".

Dimensions = 5.70mm(L) x 3.03mm(W) x 2.24mm(D-estimated) x 6%(Girdle Thickness)

Total Weight = 0.24ct (estimated - see NOTE below)

Sixteen claw set round brilliant cut diamonds, clarity is "Si", colour is "G to I" (mixed).

Dimensions = 1.42mm(Dia) x 0.87mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.68mm(Dia) x 1.02mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.20ct (estimated - see NOTE below)

Total Item Weight = 3.22 grams Total Gemstone Weight = 0.44ct Total Metal Weight = 3.13 grams (estimated)
