### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, lady's hand-assembled raised, 18ct white gold & diamond set, multistone ring.

Plain, wide, low half round, tapered band, measures 3.03mm width (at base) x 1.47mm depth, with curved underrail, open back setting, underneath.

Feature, "solitaire style" ring design, with single row stones. Comprising, a raised rub-over setting, to centre, houses one round brilliant cut diamond, rub-over set. The extended shoulders, of the band, taper up, split to a v-shaped top, Each row, contains thirty round brilliant cut diamonds, bead set, both sides.

Polished finish, hallmarked "SJC, 750, (assay Birmingham UK) circa 2006". - acid tested as 18 carat gold.  
Finger size = O.

The ring contains;

One rub-over set round brilliant cut diamond, clarity is "Vs2", colour is "G", medium cut quality.  
Dimensions = 4.42mm (average diameter) x 2.70mm (D-estimated)  
Total Weight = 0.32ct (estimated - see NOTE below).

Sixty bead set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "G to H"(mixed), medium cut quality.  
Dimensions = 1.15mm (average diameter) x 0.70mm (D-estimated)  
Total Weight = 0.30ct (estimated - see NOTE below).

Total Item Weight = 5.09 grams, Total Gemstone Weight = 0.62ct, Total Metal Weight = 4.96 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
