## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's raised 18ct white gold & diamond set, cluster ring, of cast construction.

Plain, narrow, low half round, tapered band, measures 1.47mm width (at base) x 1.20mm depth, with open back, settings, underneath.

Feature, "cluster style" ring design, with shoulder stones. Comprising a raised rub-over setting to centre, houses one round brilliant cut diamond, rub-over set. Drops to a round surround, housing twelve round brilliant cut diamonds, bead set. The extended shoulders, of the band taper up, each shoulder contains, six round brilliant cut diamonds, bead set, both sides.

Polished finish, stamped "maple leaf, 18ct MHJ" - acid tested as 18 carat gold.

Finger size L1/2.

The ring contains;

One rub-over set round brilliant cut diamond, clarity is "P1", colour is "H", medium cut quality.  
Dimensions = 4.35mm (average diameter) x 2.10mm (D-estimated)  
Total Weight = 0.24ct (estimated - see NOTE below).

Twenty Four bead set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H", medium cut quality.  
Dimensions = 1.30mm (average diameter) x 0.79mm (D-estimated) (smallest)  
Dimensions = 1.68mm (average diameter) x 1.02mm (D-estimated) (largest)  
Total Weight = 0.26ct (estimated - see NOTE below).

Total Item Weight = 2.84 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 2.74 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
