Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, flat, tapered band of 3.00mm width (at base) x 0.81mm depth, with open back settings, and a curved underrail.

Feature central white gold gold illusion plate, within a four claw setting, housing one round brilliant cut diamond, illusion set. The setting is secured to the underrail and in between the extended and square shoulders, of the plain and polished yellow gold band. Each of the shoulders is embellished with two white gold four claw settings, each housing one single cut diamond, claw set.

Polished finish.

Stamped 'W.18.D' - acid tested as 18 carat gold.

Ring size: L 1/2.

The ring contains:

One illusion set round brilliant cut diamond, clarity is "Vs", colour is "H".

Dimensions = 3.60mm(L) x 3.56mm(W) x 2.17mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.17ct (estimated - see NOTE below)

Four claw set single cut diamonds, clarity is "Vs & Si" (mixed), colour is "H".

Dimensions (average) = 1.45mm (diameter)

Total Weight = 0.05ct (estimated - see NOTE below)

Total Item Weight = 5.30 grams Total Gemstone Weight = 0.22ct Total Metal Weight = 5.26 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
