One, lady's hand finished raised, 9ct white gold & diamond set, multistone ring.

Plain, narrow, low half round, tapered band, measures, 1.54mm width (at base) x 0.78mm depth, with curved underrail.

Feature; "solitaire style" design, with shoulder stones. Comprising, araised four claw setting to centre, claw set. The extended shoulders, of the band tapers up to each side a pointed end terminations, both shoulders channel set.



Polished finish, stamped "375, GM16" - acid tested as 9 carat gold. Finger size = N.

The ring contains;

One claw set round brilliant cut diamond, clarity is "Si", colour is "H", medium cut quality.

Dimensions = 3.30mm (average diameter) x 2.01mm (D-estimated)

Total Weight = 0.13ct (estimated - see NOTE below).

Ten channel set round brilliant cut diamonds, clarity is "Si", colour is "H", medium cut quality.
