Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand finished raised, 10ct yellow gold & diamond set, cluster dress ring. Plain, narrow, low half round, tapered band, measures 2.33mm width (at base) x 1.27mm depth, with cut-out underrail, open back settings, underneath.

Feature, "step down square shaped cluster" ring design, Comprising, three bead set rows, housing a total of ninety six round brilliant cut diamonds, bead set. The extended shoulders, of the band tapers up wide to the top, from both sides.

Polished finish, stamped "10K, 1.00 TWD michael hill" - acid tested approximately 10 carat gold.

Finger size = U.

The ring contains;

- Ninety Six bead set round brilliant cut diamonds, clarity is "P1, P2 & P3"(mixed), colour is "H to J"(mixed), medium cut quality.
- Dimensions = 1.34mm (average diameter) x 0.82mm (D-estimated) (smallest)
- Dimensions = 1.50mm (average diameter) x 0.92mm (D-estimated) (largest)
- Total Weight = 1.00ct (estimated - see NOTE below).

Total Item Weight = 5.67 grams, Total Gemstone Weight = 1.00ct, Total Metal Weight = 5.47 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar material and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
