Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished, raised, 18ct white gold & diamond set, multistone ring.

Plain, wide, half round, tapered band, measures 3.13mm width (at base) x 1.11mm depth, with open back, underneath.

Feature, "cluster turbin style" ring design. Comprising, a raised dome housing forty nine round brilliant cut diamonds, various sizes, bead set. The extended shoulders, of the band tapers up to the top from both sides.

Polished finish, stamped "faded" - acid tested & x-rayed as 18 carat gold.

Finger size = J.

The ring contains;

Forty Nine bead set round brilliant cut diamonds, clarity is "Si, P1 & P2"(mixed), colour is "G to I"(mixed), medium cut quality.
Dimensions = 1.40mm (average diameter) x 0.85mm (D-estimated) (smallest)
Dimensions = 1.80mm (average diameter) x 1.10mm (D-estimated) (largest)
Total Weight = 0.75ct (estimated - see NOTE below).

Total Item Weight = 7.61 grams, Total Gemstone Weight = 0.75ct, Total Metal Weight = 7.46 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
