One, 14ct yellow gold, gem set, 'dress' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.80mm width (at base) x 0.92mm depth, with a hollow top and shoulders.

Feature central decorative cup setting, housing one button shaped freshwater pearl, cup set. The central setting is secured between the 'fluted' style shoulders of the plain and polished band.

Polished finish.

Stamped '14K CHINA IWT' - acid tested as 14 carat gold.

Ring size: N 1/2.

The ring contains:

One cup set button cultured pearl, colour is "white".

Dimensions = 11.15mm(L) x 11.10mm(W) x 8.34mm(D)

Total Item Weight = 4.82 grams

Total Metal Weight = 4.82 grams (estimated)




