Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and 9ct white gold, gem set, dress ring, of hand-assembled construction.

Plain, narrow, low half round band of 3.18mm width (at base) x 1.26mm depth.

Feature central white gold bezel setting, housing one oval natural aquamarine, bezel set. The setting is secured between the shoulders of the plain and polished yellow gold band. Each of the shoulders is embellished with 'strap' detail, and two single cut diamonds, end set.

Polished finish.

Stamped '9ct' - acid tested as 9 carat gold.

Ring size: M.

The ring contains:

One bezel set oval shaped natural aquamarine, colour is "blue".

Dimensions = 9.48mm(L) x 6.57mm(W) x 3.99mm(D-estimated)

Total Weight = 1.42ct (estimated - see NOTE below)

Four end set single cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H".

Dimensions (average) = 1.77mm (diameter)

Total Weight = 0.08ct (estimated - see NOTE below)

Total Item Weight = 3.79 grams Total Gemstone Weight = 1.50ct Total Metal Weight = 3.49 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The aquamarine is heavily abraded. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
