Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'dress' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 2.28mm width (at base) x 1.16mm depth, with open back settings.

Feature central cultured pearl, glue set. One of the extended and pointed shoulders, curls around the central setting. There are a total of thirty-four round brilliant cut diamonds, slightly graduating in size, and bead set into this shoulder. The gallery has a pierced decorative 'scroll' design.

Polished finish.

Stamped '750 unknown makers mark 042' - acid tested as 18 carat gold.

Ring size: M.

The ring contains:

One glue set off round cultured pearl, colour is "silver with pink overtones".

Dimensions = 12.64mm(Dia)

Thirty Four bead set round brilliant cut diamonds, clarity is "Si", colour is "G to H" (mixed).

Dimensions = 1.11mm(Dia) x 0.68mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.68mm(Dia) x 1.02mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 7.06 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 6.96 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
