Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, diamond set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.98mm width (at base) x 1.1mm depth, with a hollow top and shoulders, open back settings, and 'cross over' style underrail.

Feature central four claw setting, the 'cross over' style underrail creates the setting claws, housing one round brilliant cut diamond, claw set. Each of the extended and square shoulders, house one row of five round brilliant cut diamonds, slightly graduating in size, and bead set.

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: K.

The ring size:

One claw set round brilliant cut diamond, clarity is "Si2", colour is "H".

Dimensions = 4.59mm(L) x 4.58mm(W) x 2.75mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.36ct (estimated - see NOTE below)

Ten bead set round brilliant cut diamonds, clarity is "Si & P1 & P2 & P3" (mixed), colour is "H to I".

Dimensions = 1.21mm(Dia) x 0.74mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.10mm(Dia) x 1.28mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.20ct (estimated - see NOTE below)

Total Item Weight = 2.91 grams Total Gemstone Weight = 0.56ct Total Metal Weight = 2.80 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
