Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 2.45mm width (at base) x 1.03mm depth, with an open back settings, and a curved underrail.

Feature central three claw setting, housing one pear shaped natural aquamarine, claw set. Surrounding is one row of thirty-three round brilliant cut diamonds, claw set. The top plate is secured to the underrail and in between the extended and pointed shoulders, of the plain and polished band.

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: O.

The ring contains:

One claw set pear shaped natural aquamarine, colour is "blue".

Dimensions = 11.06mm(L) x 7.96mm(W) x 4.80mm(D-estimated)

Total Weight = 2.07ct (estimated - see NOTE below)

Thirty Three claw set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 1.00mm(Dia) x 0.61mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.17ct (estimated - see NOTE below)

Total Item Weight = 4.58 grams

Total Gemstone Weight = 2.24ct

Total Metal Weight = 4.13 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
