## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 14ct yellow gold and 18ct white gold, gem set, 'solitaire' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.28mm width (at base) x 1.21mm depth.

Feature central white gold four claw setting, housing one round brilliant cut diamond, claw set. The setting is secured to a white gold curved open 'elipse' shape, and sits upon the open rounded shoulders, that extend out from the plain and polished yellow gold band.

Polished finish.

Stamped '14 18K illegible stamps' - acid tested as 14 and 18 carat gold.

Ring size: R 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si1", colour is "I".

Dimensions = 3.27mm(L) x 3.20mm(W) x 1.95mm(D-estimated) x 5%(Girdle Thickness)

Total Weight = 0.13ct (estimated - see NOTE below)

Total Item Weight = 2.41 grams

Total Gemstone Weight = 0.13ct

Total Metal Weight = 2.38 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
