## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's hand-assembled raised, 18ct yellow and 18ct white gold, diamond set, solitaire ring.

Plain, narrow, low half round, tapered band, measures 1.66mm width (at base) x 0.71mm depth, with curved underrail.

Feature, "solitaire style" ring design. Comprising, a six claw white gold, coronet to top, houses one round brilliant cut diamond, claw set. The extended shoulders, of the yellow gold band, tapers up to pointed end terminations, splits to each side of the central setting.

Polished finish, stamped "A&C 750, 375" - acid tested as 18 carat gold.

Finger size H1/2.

The ring contains;

One claw set round brilliant cut diamond, clarity is "Vs", colour is "G", medium cut quality.  
Dimensions = 4.02mm (average diameter) x 2.45mm (D-estimated)  
Total Weight = 0.24ct (estimated - see NOTE below).

Total Item Weight = 2.10 grams, Total Gemstone Weight = 0.24ct, Total Metal Weight = 2.05 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
