Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's cast raised 18ct yellow gold solitaire ring, wide, half round, tapered band, measures 2.99mm width (at base) x 0.58mm depth, with cut-out underrail, open back settings, underneath.

Feature, "solitaire style" ring design. Comprising, a raised double rub-over setting, housing one round brilliant cut diamond, rub-over set. The extended shoulders, of the band, tapers up to the top, with roll over collar end terminations, to both sides.

Polished finish, stamped "18ct" - acid tested as 18 carat gold.

Finger size = L.

The ring contains;

One rub-over set round brilliant cut diamond, clarity is "Si", colour is "J", medium cut quality.
Dimensions = 4.10mm (average diameter) x 2.40mm (D-estimated)
Total Weight = 0.25ct (estimated - see NOTE below).

Total Item Weight = 4.28 grams, Total Gemstone Weight = 0.25ct, Total Metal Weight = 4.23 grams (estimated)

NOTE: Limited gemological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
