Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct yellow gold and 9ct white gold, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, flat round, tapered band of 2.57mm width (at base) x 2.57mm depth, with open back settings, and a curved underrail.

Feature 'flower' style ring, with a white gold top plate, housing nine round brilliant cut diamonds, largest to the centre, claw set. The top plate is supported with an open wire base, and is secured in between the 'split' style shoulders, of the plain and polished yellow gold band. Each of the shoulders houses three round brilliant cut diamonds, varying in size, and bead set.



Polished finish.

Stamped 'A&C 585 375 unknown makers mark" - acid tested as 9 carat gold and 14 carat gold.

Ring size: M.

The ring contains:

One claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions = 3.20mm(Dia) x 1.95mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.12ct (estimated - see NOTE below)

Fourteen claw and bead set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to J" (mixed).

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.20mm(Dia) x 1.46mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.38ct (estimated - see NOTE below)

Total Item Weight = 3.68 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 3.58 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
