Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled raised 18ct yellow and white gold & gemset, three stone ring. Plain, narrow, low half round, tapered band, measures 2.76mm width (at base) x 0.92mm depth, with curved underrail.

Feature, "trilogy style" design. Comprising, a white gold setting to top, contains one emerald cut natural aquamarine claw set, two baguette cut diamonds rub-over set. The extended shoulders, of the yellow gold band, upswept to the top, from both sides.

Polished finish, stamped "18ct, Pall" - acid tested as 18 carat gold. Finger size = P1/2.



The ring contains;

One claw set emerald cut natural aquamarine, colour is "medium light bluish".

Dimensions = 6.17mm (L) x 4.08mm (W) x 2.49mm (D-estimated)
Total Weight = 0.42ct (estimated - see NOTE below).

Two rub-over set baguette diamonds, clarity is "Vs", colour is "G to H" (mixed), medium cut quality.

Dimensions = 3.93mm (L) x 2.03mm (W) x 1.48mm (D-estimated)
Total Weight = 0.23ct (estimated - see NOTE below).

Total Item Weight = 4.40 grams, Total Gemstone Weight = 0.65ct, Total Metal Weight = 4.27 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
