## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, hand-assembled, 18ct white gold, multistone, gem set ring.

Plain, narrow, tapered band of 2.60mm in width (at base) x 1.43mm depth, with a curved underrail.

Feature central four claw setting, housing one round brilliant cut diamond, claw set. Surrounded by eighteen round brilliant cut diamonds, claw set. The base being of a four claw style, all secured between the extended shoulders of the plain and polished band. Each shoulder having seven round brilliant cut diamonds, claw set. Millegrain edging to the frame and shoulder settings.



Polished finish - stamped '750' - acid tested as 18 carat gold. Finger size is J.

The ring contains:

One claw set round brilliant cut diamond, clarity 'P1', colour 'G'.

Dimensions = 6.33mm(Dia) x 3.86mm(D-estimated) x 3%(Girdle Thickness)

Total Weight = 1.00ct (estimated - see NOTE below)

Thirty Two claw set round brilliant cut diamonds, clarity 'Vs & Si' (mixed), colour 'G to H' (mixed).

Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.56ct (estimated - see NOTE below)

Total Item Weight = 6.10 grams - Total Gemstone Weight = 1.56ct - Total Metal Weight = 5.78 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
