Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's, raised 14ct yellow gold & diamond set, multistone ring, of cast construction. Plain, narrow, low half round, tapered band, measures 2.35mm width (at base) x 1.10mm depth, with cut-out underrail.

Feature, "contured shaped" single row across the top of the band, housing twelve round brilliant cut diamonds, channel set. The extended shoulders, of the band, taper up both sides, to the setting ontop.



Polished finish, stamped "14K MHJ" - acid tested as 14 carat gold.

Finger size = R1/2.

The ring contains;

Twelve channel set round brilliant cut diamonds, clarity is "P1 & P2"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 1.90mm (average diameter) x 1.16mm (D-estimated) (smallest)

Dimensions = 2.21mm (average diameter) x 1.35mm (D-estimated) (largest)

Total Weight = 0.48ct (estimated - see NOTE below).

Total Item Weight = 2.70 grams, Total Gemstone Weight = 0.48ct, Total Metal Weight = 2.60 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
