## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's hand-assembled, raised 18ct white gold & gemstone set (mixed), multistone ring. Plain, wide, low half round, tapered band, measures, 4.54mm width (at base) x 1.51mm depth, with curved underrail.

Feature, "cluster style" ring design. Comprising, a square-shaped, dimensions spiral, with open back settings underneath. Housing ninety five, round faceted, natural sapphires bead set. To the outer border & running to one shoulder, contains forty round brilliant cut diamonds, bead set. The extended shoulders, of the band tapers up to the top, one side underneath, the other side, forms the start of the square shaped spiral.



Polished finish, stamped "750, 551, 9, 6" - acid tested as 18 carat gold. Finger size = N.

The ring contains;

Ninety Five bead set round natural sapphires, colour is "medium-light to dark pink".  
Dimensions = 1.86mm (average diameter) x 1.13mm (D-estimated) (smallest)  
Dimensions = 1.99mm (average diameter) x 1.21mm (D-estimated) (largest)  
Total Weight = 3.35ct (estimated - see NOTE below).

Forty bead set round brilliant cut diamonds, clarity is "Vs & Si"(mixed), colour is "G to H"(mixed), medium cut quality.  
Dimensions = 2.20mm (average diameter) x 1.34mm (D-estimated)  
Total Weight = 1.60ct (estimated - see NOTE below).

Total Item Weight = 21.67 grams, Total Gemstone Weight = 4.95ct, Total Metal Weight = 20.68 grams, (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
