Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled raised, 18ct yellow gold & opal set, cluster dress ring. Plain, narrow, flat, low half round, tapered band, measures 2.77mm width (at base) x 1.03mm depth, with cut-out underrail, open back settings, underneath.

Feature, "pyramid style" cluster ring. Comprising, three tier cluster drop, housing nineteen round cabochon cut white crystal opals, all claw set. With a double rope twist surround at base. The extended shoulders, of the band, tapers up to the wire basket setting support underneath.

Polished finish, stamped "18K" - acid tested as 18 carat gold.

Finger size = S1/2.

The ring contains;

- Nineteen claw set round white crystal opals, cabochon-cut, with rolling flash pattern, of green, blue, yellow play of colours.
- Dimensions = 2.89mm (average diameter) x 1.00mm (D-estimated) (smallest)
- Dimensions = 4.13mm (average diameter) x 1.50mm (D-estimated) (largest)
- Total Weight = 1.14ct (estimated - see NOTE below).

Total Item Weight = 5.70 grams, Total Gemstone Weight = 1.14ct, Total Metal Weight = 5.47 grams (estimated)

NOTE: Limited gemmological testing inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
