Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished, raised 10ct white gold & diamond set, multistone ring. Plain, wide, low half round, tapered band, measures 2.84mm width (at base) x 1.36mm depth, tapers up to 7.90mm width (at top), with cut-out underrail, open back settings, underneath.

Feature, "cluster style" ring design. Comprising, seven alternating rows, across the top of the band. Housing one hundred & fifty seven round brilliant cut diamonds, pave set. The extended shoulders, of the band, tapers up wide to the top, from both sides.

Polished finish, stamped "10K, michael hill, 1.00 TDW" - acid tested approximately 10 carat gold.



Finger size = 0.

the ring contains;

One Hundred And Fifty Seven pave set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "G to H"(mixed), medium cut quality.

Dimensions = 1.05mm (average diameter) x 0.64mm (D-estimated) (smallest)

Dimensions = 1.16mm (average diameter) x 0.71mm (D-estimated) (largest)

Total Weight = 1.00ct (estimated - see NOTE below).

Total Item Weight = 3.94 grams, Total Gemstone Weight = 1.00ct, Total Metal Weight = 3.74 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
