## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct white gold, gem set, multistone, 'cluster' style ring, of handmade construction.

Plain, narrow, low half round band of 2.09mm width (at base) x 1.22mm depth, with open back settings, and a curved underrail.

Feature central eight claw setting, housing one emerald cut natural sapphire, claw set. Surrounding is one row of eight round brilliant cut diamonds, creating a scalloped edge, bead set. The top plate is supported with a decorative gallery, and in between the extended and square shoulders, of the plain and polished band.

Polished finish.

Stamped '18CT PAL' - acid tested as 18 carat gold.

Ring size: M 1/2.

The ring contains:

One claw set emerald cut natural sapphire, colour is "blue".

Dimensions = 6.54mm(L) x 6.06mm(W) x 3.72mm(D-estimated)

Total Weight = 1.47ct (estimated - see NOTE below)

Eight bead set round brilliant cut diamonds, clarity is "Vs & Si & P1" (mixed), colour is "G".

Dimensions (average) = 3.45mm(Dia) x 2.10mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 1.28ct (estimated - see NOTE below)

Total Item Weight = 4.98 grams Total Gemstone Weight = 2.75ct Total Metal Weight = 4.43 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
