Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, gem set, 'three stone' style ring, of hand-assembled construction.

Plain, wide, low half round band of 4.58mm width (at base) x 1.19mm depth, with open back settings.

Feature one central bezel setting, housing one round brilliant cut diamond, bezel set. Either side of the central setting, is one bezel setting, each housing one old cut diamond, bezel set. The settings are secured to the top of the plain and polished band.

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: N.

The ring contains:

- One bezel set round brilliant cut diamond, clarity is "Vs", colour is "H".
Dimensions = 4.01mm(Dia) x 2.36mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.24ct (estimated - see NOTE below)
- Two bezel set old cut diamonds, clarity is "Vs", colour is "J to L" (mixed).
Dimensions (average) = 3.62mm(L) x 3.50mm(W) x 2.14mm(D-estimated)
Total Weight = 0.34ct (estimated - see NOTE below)

Total Item Weight = 5.46 grams Total Gemstone Weight = 0.58ct Total Metal Weight = 5.34 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
