Valuation for Traditional Retail Insurance Replacement

Item 1

One pair of hand-assembled, 18ct yellow gold, diamond set, earrings.

Feature elongated and hinged, 'hoop' style earring design. Each earring claw set with twentytwo round brilliant cut diamonds to the front section.

The back half of a plain and polished design.

Post fittings, with the back halves forming the hinged back arm locking mechanisms.

Stamped '750 RT' - acid tested as 18 carat gold.

Earring dimensions = 20.00mm (ave. length) x 2.60mm to 2.50mm (width) x 2.10mm (ave. depth).

The earrings contain:

Forty Four claw set round brilliant cut diamonds, clarity 'Si', colour 'H'. Dimensions (average) = 1.75mm(Dia) x 1.10mm(D-estimated) x 2%(Girdle Thickness) Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 5.75 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 5.55 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
