Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, multistone, gem set ring, of cast construction. Plain, narrow, tapered band of 2.64mm in width (at base) x 1.03mm depth, with a curved and pierced, large 'lattice' style underrail.

Feature central 'cluster' style setting, housing thirteen round brilliant cut diamonds, largest to the centre, surrounded by six round brilliant cut diamonds (next largest), and six of the smallest round brilliant cut diamonds, all claw set. Finishing with an outer row being claw set with sixteen round brilliant cut diamonds (largest of the smalls). A multi-wire support base, all secured between the shoulders of the plain and polished band. Each shoulder having a central row of four baguette cut and tapered baguette cut (mixed) diamonds, surrounded three sides by nine round brilliant cut diamonds alternating in size, claw set. Polished finish - stamped 'TW' (partial) - acid tested as 9 carat gold. Finger size is K.



The ring contains:

Seven claw set round brilliant cut diamonds, clarity 'P1', colour 'H to I' (mixed).

Dimensions = 2.75mm(Dia) x 1.63mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.65mm(Dia) x 2.20mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.60ct (estimated - see NOTE below)

Forty claw set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'H to I' (mixed).

Dimensions = 1.40mm(Dia) x 0.85mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.25mm(Dia) x 1.35mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.10ct (estimated - see NOTE below)

Eight channel set tapered baguette diamonds, clarity 'Si & P1' (mixed), colour 'H'.

Dimensions (average) = 2.16mm(L) x 1.08mm(W) x 0.70mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.30ct (estimated - see NOTE below)

Total Item Weight = 7.12 grams - Total Gemstone Weight = 2.00ct - Total Metal Weight = 6.72 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
