Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished, raised 9ct yellow gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 1.99mm width (at base) x 1.17mm depth, with curved underrail.

Feature, "cluster style" ring design, with shoulder stones. Comprising, a raised pear-shaped cluster setting to top, claw set. The extended shoulders, of the band, tapers up, splits at the end, claw set both sides.

Polished finish, stamped "375, JP88" - acid tested as 9 carat gold.

Finger size = O.

Eight claw set round brilliant cut diamonds, clarity is "Si", colour is "brown tint", medium cut quality.

Dimensions = 1.80mm (average diameter) x 1.10mm (D-estimated) (smallest)

Dimensions = 2.20mm (average diameter) x 1.34mm (D-estimated) (largest)

Total Weight = 0.34ct (estimated - see NOTE below).

Fifty claw set round brilliant cut diamonds, clarity is "Si", colour is "H - I"(mixed), medium cut quality.

Dimensions = 1.00mm (average diameter) x 0.61mm (D-estimated) (smallest)

Dimensions = 1.50mm (average diameter) x 0.92mm (D-estimated) (largest)

Total Weight = 0.66ct (estimated - see NOTE below).

Total Item Weight = 3.03 grams, Total Gemstone Weight = 1.00ct, Total Metal Weight = 2.83 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
