Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand-assembled raised, 10ct white gold & diamond set, multistone ring. Plain, wide, low half round, tapered band, measures 4.83mm width (at base) x 1.49mm depth, with cut-out underrail, open back settings, underneath.

Feature, "illusion cluster" ring style with shoulder stones. Comprising, a rectangulat four claw setting to top, centre, houses twelve Princess cut diamonds, illusion claw set. The extended shoulders, of the band, tapers up wide to the top. Each shoulder terminates with three channel row settings, contains a total of twenty four round brilliant cut diamonds (twelve each), channel set, both sides.



Polished finish, stamped "10K" - acid tested approximately 10 carat gold.

Finger size = S.

The ring contains;

Twelve illusion claw set Princess cut diamonds, clarity is "Si & P1"(mixed), colour is "G to H"(mixed), medium cut quality.

Dimensions = 2.56mm (L) x 2.53mm (W) x 1.80mm (D-estimated)

Total Weight = 1.20ct (estimated - see NOTE below).

Twenty Four channel set round brilliant cut diamonds, clarity is "P2 & P3"(mixed), colour is "G to H"(mixed), medium cut quality.

Dimensions = 2.11mm (average diameter) x 1.29mm (D-estimated)

Total Weight = 0.80ct (estimated - see NOTE below).

Total Item Weight = 10.89 grams, Total Gemstone Weight = 2.00ct, Total Metal Weight = 10.49 gram (estimated)

NOTE: Limited gemmological testing, inset. Some of the Princess cut diamonds are chipped. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
