### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, lady's hand finished raised, 14ct yellow gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 1.43mm width (at base) x 0.97mm depth, with open back, settings underneath.

Feature, "cluster style" ring design, with shoulder stones. Comprising, a raised four claw setting to centre, houses one early brilliant cut diamond, claw set. Drops to a carousel surround, contains forty round brilliant cut diamonds, claw set. The extended shoulders, of the band sweeps up, each shoulder containing ten round brilliant cut diamonds, claw set, to both sides.

Polished finish, stamped "14K" - acid tested as 14 carat gold. Finger size = M1/2.



The ring contains;

One claw set early brilliant cut diamond, clarity is "P1", colour is "J", medium cut quality.  
Dimensions = 5.80 - 5.92mm (diameter) x 3.75mm (D-estimated) x 3%(Girdle Thickness)  
Total Weight = 0.90ct (estimated - see NOTE below).

Sixty claw set round brilliant cut diamonds, clarity is "P1", colour is "I to J"(mixed), medium cut quality.  
Dimensions = 1.38mm (average diameter) x 0.84mm (D-estimated)  
Total Weight = 0.60ct (estimated - see NOTE below).

Total Item Weight = 2.72 grams, Total Gemstone Weight = 1.50ct, Total Metal Weight = 2.42 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
