Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, flat band of 2.67mm width (at base) x 1.41mm depth, with open back (cut out) settings, and a curved underrail.

Feature central bezel setting, housing one Princess cut diamond, bezel set. Surrounding is one row of sixteen round brilliant cut diamonds, claw set. The top plate is secured to the underrail, and the extended and square shoulders, of the plain and polished band. Each of the shoulders houses one row of six round brilliant cut diamonds, claw set. Millegrain detail to the edges of the settings.

Polished finish. Stamped '750 T' - acid tested as 18 carat gold. Ring size: K.

The ring contains:

One bezel set Princess cut diamond, clarity is "VS", colour is "G".

Dimensions = 3.50mm(L) x 3.50mm(W) x 2.48mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.23ct (estimated - see NOTE below)

Twenty Eight claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions = 1.35mm(Dia) x 0.82mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.65mm(Dia) x 1.01mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.39ct (estimated - see NOTE below)

Total Item Weight = 6.48 grams Total Gemstone Weight = 0.62ct Total Metal Weight = 6.36 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
