Valuation for Traditional Retail Insurance Replacement

One, 18ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, flat band of 2.13mm width (at base) x 1.05mm depth, with open back settings.

Feature central decorative six claw setting, housing one round brilliant cut diamond, claw set. The setting is secured between the shoulders, of the plain and polished band. Each of the shoulders houses one row of five round brilliant cut diamonds, bead set.



Polished finish.

Stamped '750 TJ(unknown makers mark)' - acid tested as 18 carat gold.

Ring size: K 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P2", colour is "G".

Dimensions = 6.29mm(L) x 6.27mm(W) x 4.10mm(D-estimated) x 4%(Girdle Thickness)

Total Weight = 1.03ct (estimated - see NOTE below)

Ten bead set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 1.85mm(Dia) x 1.13mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.26ct (estimated - see NOTE below)

Total Item Weight = 3.30 grams Total Gemstone Weight = 1.29ct Total Metal Weight = 3.04 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
