## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 14ct yellow gold. gem set, 'cluster' style ring, of hand finished construction.

Plain, narrow, low half round band of 1.70mm width (at base) x 1.28mm depth.

Feature central three claw setting, housing one pear shaped diamond, claw set. To the bottom of the central diamond, is one curved row of seven shared claw settings, each housing one round brilliant cut diamond, claw set. The settings are secured between the shoulders of the plain and polished band.

Polished finish.

Stamped 'w' - acid tested as 18 carat gold.

Ring size: L.

The ring contains:

One claw set pear shaped diamond, colour is "black".

Dimensions = 7.97mm(L) x 6.40mm(W) x 3.51mm(D-estimated) x 7%(Girdle Thickness)

Total Weight = 1.17ct (estimated - see NOTE below)

Seven claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 1.80mm(Dia) x 1.10mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.18ct (estimated - see NOTE below)

Total Item Weight = 4.41 grams Total Gemstone Weight = 1.35ct Total Metal Weight = 4.14 grams (estimated)

NOTE: The black gemstone may possibly be treated black diamond or treated synthetic black moissanite. Limited testing, whilst set, cannot determine the nature of these gemstone. Therefore, the black gemstones require removal from their settings for full and accurate gemmological testing. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
