One, 18ct white gold, gem set, 'solitaire' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.16mm width (at base) x 0.90mm depth.

Feature central 'tulip' style decorative four claw setting, housing one round brilliant cut diamond, claw set. The setting is secured between the extended and pointed 'ramp' style shoulders, of the plain and polished band.



Polished finish.

Stamped 'G18K D1.01ct' - acid tested as 18 carat gold.

Ring size: M.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Vs2", colour is "H".

Dimensions = 6.29mm(L) x 6.23mm(W) x 4.00mm(D-estimated) x 5.5%(Girdle Thickness)

Total Weight = 1.01ct (known weight - see NOTE below)

Total Item Weight = 4.05 grams Total Gemstone Weight = 1.01ct Total Metal Weight = 3.85 grams (estimated)

NOTE: The diamond has been certified by Messrs. Gemological Institute of America (GIA) Certificate number: 7231353272 Dated: August 04, 2016. The diamond has also been laser inscribed upon the girdle with GIA (logo) and 7231353272. Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.




