## Valuation for Traditional Retail Insurance Replacement

### Item 1

One pair of, 14ct yellow gold and 14ct rose gold, gem set, stud earrings, of hand-assembled construction.

Feature central cultured pearl, cup set. Surrounding is yellow gold and rose gold decorative 'twist' style elements, and one rose gold bezel setting, each housing one round brilliant cut diamond, bezel set. The earrings are finished with post and butterfly attachments.

Earring dimensions = 16.10mm (ave. length) x 9.50mm (ave. width) x 8.78mm (ave. depth).

Polished finish.

Stamped '585' - acid tested as 14 carat gold.

The item contains:

Two end-drilled semi-round cultured pearls, colour is "white".

Dimensions = 8.00mm (Dia)

Two bezel set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H to I" (mixed).

Dimensions (average) = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.03ct (estimated - see NOTE below)

Total Item Weight = 4.67 grams

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
