Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'cluster' style ring, of handmade construction.

Plain, narrow, low half round band of 2.21mm width (at base0 x 1.34mm depth, with open back settings, and a curved underrail.

Feature 'flower' style cluster ring. White gold top plate housing nine round brilliant cut diamonds, largest to the centre, and bezel set. The top plate is secured to the underrail, and in between the extended and pointed 'split' style shoulders, of the plain and polished yellow gold hand.



Polished finish, S

Stamped '750' - acid tested as 18 carat gold.

Ring size: O.

The ring contains:

One bezel set round brilliant cut diamond, clarity is "Si2", colour is "H".

Dimensions = 4.00mm(Dia) x 2.44mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.23ct (estimated - see NOTE below)

Eight bezel set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "G to I" (mixed).

Dimensions = 2.50mm(Dia) x 1.53mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.65mm(Dia) x 1.62mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.54ct (estimated - see NOTE below)

Total Item Weight = 3.88 grams Total Gemstone Weight = 0.77ct Total Metal Weight = 3.73 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
