Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished, raised 14ct white gold & gemset, dress ring.

Plain, wide, low half round, tapered band, measures 3.13mm width (at base) x 1.72mm depth, with open back, setting underneath.

Feature: "solitaire style" dress ring. Comprising, a raised four claw railed setting to top, houses one tourmaline, claw set. The extended shoulders, of the band, tapers up to below the stone from both sides.

Polished finish, stamped "14K" - acid tested as 14 carat gold.

Finger size = J.

The ring contains;

One claw set square cushion- shaped, faceted, pink (rose) tourmaline, colour is "very light".
Dimensions = 14.70mm (L) x 14.70mm (W) x 8.40mm (D-estimated) x 5%(Bulge)
Total Weight = 14.00ct (estimated - see NOTE below).

Total Item Weight = 7.45 grams, Total Gemstone Weight = 14.00ct, Total Metal Weight = 4.65 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weights of the gemstone are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstone require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
